Regularly reviewing and updating your Will and Power of Attorney documents are important to ensure your Will remains legally valid and that your health and financial decisions are managed by someone you trust.



Will and Power of Attorney Checklist

Use this checklist to determine if your Will or Power of Attorney documents need to be reviewed and updated.

Changes in the family Changes in family structure may affect who you'd like to benefit from your estate. Marry Divorce Remarry Widow Birth of children or grandchildren
Changes in assets Significant increases or decreases in the value of your estate can affect your Will. Purchased a property or business Sold a property or business
Changes in relationships Consider if there have been changes to beneficiaries, dependents or the executor of your Will. Estrangement with anyone named in your Will The executor of your will is no longer willing or able to carry out their duties Your appointed Attorney is no longer willing or able to carry out their duties The financial needs of your dependents changed significantly
Changing your executor Family members are often appointed as executors; however, you can choose to relieve the burden and stress by appointing a professional executor instead. You want to appoint a professional executor like State Trustees You want to appoint a different family member or friend

Relocation Moving interstate or overseas may affect the validity of your Will, and the ability
of your named Attorney to be able to act in a timely manner.

How to update your Will or Power of Attorney

If there are changes required to your Will or Power of Attorney, a new document is required. The new document will state that it revokes all previous versions, ensuring that only the most updated version is valid.

Remote, regional or mobility issues

A Will and Power of Attorney dictionary

Save this handy glossary of legal terminology and feel confident about the process of estate planning.



Beneficiary

A person who is given a gift or other benefit under a Will.

Charitable trust

A monetary gift in your will can be held in a charitable trust that provides ongoing financial support to your chosen charity or cause. It's possible to do this via an already-established perpetual charitable trust like the State Trustees Australia Foundation, or we can set up a private charitable trust for you.

Estate

All property and possessions owned by a person, whether solely or with one or more other persons

Executor

A person or organisation appointed by a testator in a will to carry out the provisions of the Will. Sometimes referred to in a Will as 'my executor and trustee' or simply 'my trustee'

Intestacy

The situation arising upon the death of a person who hasn't left a valid Will or has failed to give away the whole of their property in their Will.

Letter of administration

A document issued by the court confirming the appointment of an administrator to administer the estate of a deceased person where there is no valid Will, or no executor has been appointed, or if the appointed executor is unable or unwilling to act in that capacity.

Probate

A document issued by the court confirming that a Will has been proved (determined) as valid, and authorising the person or organisation named in the will as executor to administer the estate.

Residuary estate

What is left of a deceased person's property and possessions after funeral and administration expenses, debts and other liabilities have been paid and specific gifts have been distributed.

Testator

A person who makes a Will.

Trustee

A person or organisation that holds property for another under a trust. In a Will, it is quite common for the 'executor' and the 'trustee' to be the same person or organisation.

Power of attorney

A Power of Attorney lets you choose someone you trust, called an Attorney to step in and make decisions on your behalf when you are unable to do so.

Enduring power of attorney (EPA)

An 'Enduring' Power of Attorney means that your Power of Attorney continues even if you lose decision making capacity.

Enduring Power of Attorney (Financial)

Appoint a person or professional to manage your financial affairs, including any related legal matters. You can appoint State Trustees as your Enduring Power of Attorney (Financial)

Enduring Power of Attorney (Personal)

Appoint a person or professional to make non-medical decisions relating to your personal situation and lifestyle. You cannot appoint State Trustees as your Enduring Power of Attorney (Personal)

Medical Treatment / Appointment of Medical Treatment Decision Maker

Similar to a Power of Attorney, this document allows you to appoint a person or professional to legally make medical treatment decisions in the event you can't due to injury or illness. You cannot appoint State Trustees as your Medical Treatment Decision Maker.
